#### Ellen Clippinger:

Ellen Clippinger is the founder and Executive Director of AYS, Inc., formerly At-Your-School Child Services, a not-for-profit-youth-serving agency operating 50 programs in the Indianapolis, Indiana, community. Ellen has been instrumental in piloting middle school programs, a cooperative preschool with wrap-around child care, and wraparound programs for kindergarten children. Resource and referral services and a professional development center complement the range of services provided by AYS. Ellen is currently the President of the Indiana National School-Age Consortium (ISAC). In addition, Ellen is the founder and Co-Chair of Voices for Children, a statewide organization encouraging partnerships and collaborations for developing quality care and education for all children and families in Indiana. She is President of the Marion County Step Ahead Council and board member of both the Indiana Child Care Fund Board and the Indiana Professional Development System. Appointed to the Board for the Coordination of Child Care regulation in 1997, Ellen works with State legislators to formulate policy on children's issues and make recommendations to the Indiana State Legislature. In addition, Ellen is an Education Training Associate for the National Institute on Out-of-School Time at the center for Research on Woman at Wellesley College.

Parkway south to Turnpike South. Take turnpike south to exit 8A, after paying the toll bare right to Route 32 north. Go past first light to fork in road – bare right; this will be Route 130 north.
